Convene

Travis Paddock called the meeting of the Richland County Board to order at 7:00pm on June 12, 2025, in the Jail Meeting Room. The meeting was proclaimed open, the Pledge of Allegiance recited, and Prayer was led by Willard Anderson. Changes/Approval of Agenda

Cindy Given made a motion to approve the agenda. Dennis Graves seconded the motion. Motion carried.

Cheryl Welker was in attendance and questioned why two part-time animal control employees were being suspended without pay. The board informed her that there would be discussion in executive session.

Motion/Vote - Consent Agenda

Dennis Graves made a motion to approve all items under the consent agenda. Alexis McFarland seconded the motion. Motion/Vote - Finance Committee

Travis Paddock discussed the claims. Claims totaling \$267,101.93 total county and \$332,095.25 non-county. Travis Paddock made a motion to approve the claims. Alexis McFarland seconded the motion. Motion carried.

Sheriff's Report

Sheriff Andrew Hires discussed the Radio Bid project. He received two different bids. VEI had a bid of \$328,982.19 and GTSi had a bid of \$711,324.00. Sherriff Hires stated that the bids are different because of the two companies bidding different equipment. The new radios will give 95% County coverage with four channels; County Sheriff's office, Olney Police, All Fire Departments and the fourth channel would be available in the event of a natural disaster. The deadline to decide on a bid is June 30, 2025. David Holt with VEI was in attendance and spoke about their bid.

Corey also discussed CrowdStrike, which is a cybersecurity company specializing in endpoint protection, threat intelligence, and response services. The state of Illinois offers this service free of charge for the County. There was discussion about updating all security features in the courthouse and jail, but it would be costly. Sheriff Hires then discussed the possibility of key fobs outside of each cell block and new technology that can read the inmates heartrate and movement from outside of the cell.
