Motion/Vote - Consent Agenda

Cindy Given made a motion to approve all items under the consent agenda. Alexis McFarland seconded the motion. Items approved were the minutes from April 10, 2025 for County Board, May 2, 2025, for Road and Bridge meeting, and March 26, 2025, for 911 ETSB meeting; the county officer reports; Re-appointment of Linda Brown to the Board of Review for a 2 year term; Re-appointment of Chuck Diel to the Richland County Farmland Assessment Review Committee for a 3 year term; Resolution of Support and Commitment of funds with Greater Wabash Regional Planning Commission; Raffle license for Pride Richland County Pride Fest 2025; Petition from German Township for culvert assistance; #2 and 2A Pay estimate totalling \$564,124.85 (CDBG grant); Change order #1 for \$11,410.00 for increase of quantities (CDBG grant).

State's Attorney's Report

Chelsey Clark stated that in 2025, there have been 12 DUI cases, 50 misdemeanor cases and 100 felony cases thru May 8, 2025.

Highway Business

County Engineer Dan Colwell discussed OSHA training set for May 29th. He also discussed IECC training for CDL, willing to reimburse Highway employees to take the CDL classes in June.
