#### Convene

Chairman Dennis Graves called the meeting of the Richland County Board to order at 7:00pm on July 13, 2023, at the Jail Meeting Room. The meeting was proclaimed open, the Pledge of Allegiance recited, and a Silent Prayer was offered. Brian Vanblaricum asked if the dogs are aggressive towards people, and she said "Yes". Andrew Hires was present and discussed the laws with her. When asked if the dogs were still running loose once Animal Control and Deputy arrived, Andrea with Animal Control said they were not. Andrea stated that most times when they are called out, the dogs are usually back home by the time they arrive. Andrew Hires stated that people must call for the Sheriff's Department to be able to do anything in the future. Steve Schonert asked Andrea to make rounds through Calhoun and other villages periodically. Steve Schonert thanked Ms. Gibson for her concern.

#### **Old Business**

Steve Schonert made a motion to approve items 3-7. Brian Vanblaricum seconded the motion. The motion was passed by vote: Brian VanBlaricum (Yes), Dennis Graves (Yes), Travis Paddock (Yes) Shawn Rose (Yes), Cindy Given (Yes), Steve Schonert (Yes), Morgan Henton (Yes). Items approved were &9,569 payment of additional squad car costs from ARPA funds; set aside \$20,000 for improvements needed for Eckiss building; set aside \$52,425 for jail intercom system – balance after grant of \$20,000; set aside \$2,000 for Richland County Fair for cpr/aed kit at Fairgrounds; the use of \$136,000 from ARPA to repair and replace 911 signs in the county.

Steve discussed item 14B – Key fob entry for courthouse, Steve was against this for \$26,000 and stated there was a misunderstanding about how this would be paid. John Clark is still reviewing item 14C – County Ordinance for Solar Farm Installation.
